Resolved: that objections to the application be submitted on the grounds that:

- it is likely to prevent a similar development to the adjacent property without it leading to a 'terracing' effect as whole gap between properties would be filled
- the car port appears too narrow for a vehicle to use and is likely to make the garage unusable for a vehicle therefore all cars for the property would then park on the road conflicting with the Moulton Village Design Statement
- from a building regulations point of view the extension appears to be carried on two small back piers; regulation may require a better structural support
