# MINUTES OF A MEETING OF MOULTON PARISH COUNCIL held at MOULTON VILLAGE HALL on MONDAY 11<sup>th</sup> JULY 2011 at 7.15pm

Brian Cartwright gave a presentation on CHAIN (Cheshire Anti Incinerator Network) and its current fight against the appeal submitted by TATA Brunner Mond to overturn the decision to refuse the building of an incinerator at Lostock Gralam. He outlined the role of the organisation and highlighted the following:

- there are or have been a number of proposals to incinerate waste for this area

- the pre-enquiry meeting is to be held in Northwich at the end of July
- he believes there is enough capacity in Cheshire with two current plants this development would result in lorries bringing waste from outside Cheshire
- there are issues about safety although it is claimed there are no fumes why is a high chimney needed
- will be a major addition to traffic issues in the area
- have a 25,000 signed petition against the development
- are seeking funds to help with the fight against the appeal

The Chair thanked Mr. Cartwright for his presentation.

Mrs. D. Bennett, Parish Council nominated Moulton School Governor gave a brief report outlining the business of the School during the last school year. She highlighted her meetings' attendance details, school developments and other issues managed during the year. Particular reference was improved interaction between Governors and Staff, her involvement with the Y6 class, the future use of the old canteen and that all places for the new intake is full for September 2011. A question was raised regarding the impact on this for any child from the village needing a place during the coming year and it was reported that some children living in the village cannot get places. Noted that Cheshire West and Chester Council have an admissions policy which includes the criteria applied to allocate places at an oversubscribed school.

The Chair thanked Mrs. Bennett for her report and for carrying out the Governor role on behalf of the Parish Council.

# 11.07.02 Public Open Session

The meeting commenced with a 15 minute session during which members of the public had the opportunity to raise questions and seek clarification in relation to village and community matters.

The only matter raised was to report the success of the Crow Fair including the involvement of staff from Veolia. The Council expressed its thanks and congratulations to the Events Committee.

PCSO Kat Stock submitted her latest monthly report, including reference to a small number of low level anti-social incidents, some crimes including damage and lead theft and to report that an ANPR operation had been undertaken locally. Kat also advised that she is giving a monthly talk to the Yr6 group at the School

# 11.07.04 Clerk's Report

Resolved: that

a) the Clerk's report relating to progress on a number of current matters be received;

- b) arising from the report it was noted that:
  - Re the safety issues at the Brick Kiln Lane junction onto the by-pass a survey of the number of buses that undertake to turn left to use the Peckmill roundabout in order to get to Winsford and a survey of the volume of traffic using the Brick Kiln Lane and the Peckmill junctions to compare difference in use will be undertaken
  - re the footway/cycle way on Davenham bypass we are advised there is a pedestrian/cycle route off the southern end of the bypass along bridleway Bostock BR4 which offers the safe alternative route
  - Mr. Ford, owner of Bank Farm, is aware of the grant to put the area of the barrow in the Natural England Stewardship Scheme and is happy for the erection of a suitable notice in an agreed place regarding its location
  - Clirs. Bowie and Wood are looking to organise a first joint Parishes walk in the autumn
  - Cllr. Burgess on his attendance at Cheshire West and Chester Council's Rural Conference at Oulton Park on 23<sup>rd</sup> June from which the importance of the development of Neighbourhood Planning was noted
  - Cllr. Bowie reported on her attendance at a seminar regarding The Localism Bill at Crewe on 29<sup>th</sup>
    June at which the Bill was reported to be only at its very early stage with the likelihood that more
    revisions will be introduced
  - village community and voluntary groups have been advised of the availability of grants from the Council and provided with the usual details of how to apply

#### Resolved: that

- a) Cheshire West and Chester be advised that the Bostock RB4 is not easily usable, mainly due to it passing through farm property and the information post being marked only as a footway
- b) the following action regarding the barrow be taken:
  - meet with the relevant officer from Cheshire West and Chester Council to progress the location sign
  - establish what, if any, surveys have taken place and what information was found and contact with the Manchester and Liverpool Universities' Archaeological Departments about researching information to provide a historical context for the barrow

**Resolved:** that a donation of £100 be made to CHAIN to support its involvement in the public inquiry into the erection of an incinerator at Lostock

Received the notes of the meeting with tenants held on Saturday 18<sup>th</sup> June 2011 at 10.30am at the Village Hall. Noted the Garages Area Committee are progressing the various actions.

i) Best Kept Garden Competition

Noted the arrangements for initial judging were almost completed and the Manager of the Garden Centre at The Hollies has kindly agreed to carry out the final judging in early August.

ii) Christmas Tree Lighting Event

Noted some initial arrangements made (Barnton Band is booked). Further report at the next meeting.

Noted that the management of the Village Hall will be the responsibility of St. Stephen's PCC with effect from 1<sup>st</sup> September 2011 and handover arrangements are underway. The PCC has made a strong commitment to enable the Hall to continue to be used as a community facility and is currently bringing together representatives of the Hall users to form a Group to support this new arrangement

- a) MADCA be thanked for its significant contribution to the community through its management of the Hall for the past 30 years and the new Group be wished every success
- b) the Parish Council will continue to support the Hall, the details of which will be considered at the end of the meeting and due to the confidential nature of the matter at this point in time, members of the public and the press be excluded and they be instructed to withdraw for that item
