## 1. Chair's Welcome and Opening Remarks

## 5. Parish Council Chair's Annual Report for 2012/13

# 7. Moulton Village Survey 2013 – Presentation of Results

The Parish Clerk gave a summary of the findings of the Survey. A copy of the Results is to be posted on the Parish Council Web Site. The need to now progress the Neighbourhood Plan was also outlined – volunteers will assist the Parish Councillors in formulating a draft Plan in the coming months.

# 8. Open Forum - General Matters Raised by Electors Present

The colour of the Roof Tiles on the recently renovated farmhouse on Jack Lane was questioned. The Parish Clerk will check the terms of the Planning Permission and, if appropriate, refer the matter to CWAC Planning Department.

The possibility of Boundary changes being implemented was raised. The Parish Clerk confirmed that a full review of Parish and Town Boundaries is currently being undertaken by CWAC, with Moulton due for overview in 2014. No boundary changes can be implemented without full, community wide consultation having taken place.

Recent complaints over the Planning Process, and the role of Planning Officers, were raised. These formal complaints, including one from the Parish Council, are currently being investigated by CWAC. Primary concerns relate to the transparency of the consultation process, the quality of the advice given by consultees and the input, at Committee Stage, from Planning Department personnel.

It was confirmed that the Precept for 2013/14 is £29,670.
